General Information on Visas

- 1. Passport. Must be valid at least 6 months. Make sure that the passport has at least ONE completely empty visa page.
- 2. 1 Copy of Passport. The page(s) shows your photo, name, date and place or birth and the expiration date of passport.
- 3. <u>Photo.</u> Two passport-type photos, 2" x 2", color, front-view, taken within 6 months, and write your name and last name on the back of each photo.
- 4. <u>Visa Application Form.</u> Must be fully completed and signed by the applicant and accompanied with all required documents. Parents can sign for the minor.
- 5. <u>Fees.</u> Transit visa \$35 per entry / Tourist visa \$40 per entry (No multiple entry) / Non-immigrant visa \$80 (Single-entry), \$200 (Multiple-entry). The fee must be paid in the form of <u>MONEY ORDER</u> or <u>CASHIER'S CHECK only</u> payable to "ROYAL THAI CONSULATE GENERAL-LOS ANGELES". Cash, personal or company checks are NOT acceptable. (Fees are subjected to change without further notice, please check <u>www.thaiconsulatela.org</u> for the last update.)
- 6. <u>Airline Ticket</u>. If required to submit, only a copy of <u>confirmed airline tickets</u> showing IN and OUT of Thailand must be submitted. Either <u>paper ticket</u> or <u>confirmed e-ticket</u> is acceptable. <u>No itinerary or passenger receipt</u> (the last page of your ticket) is accepted.
- 7. Recent Bank Statement.
- 8. <u>Processing Time</u>. If apply in person, take at least 2 business days. If apply by mail, take at least 15 business days, not including mailing time.
- 9. If apply by mail, a self-addressed stamped envelope with sufficient postage (Express Mail recommended) must be included for the return of passport. **Metered stamp will not be accepted**, please use regular stamp.
- 10. List of countries allowed a "30-DAY STAY IN THAILAND WITHOUT A VISA" for TOURISM Must have a valid passport (6-month validity with empty visa pages), proof of confirmed round trip tickets showing 30 days or less in Thailand. Extension of stay will not be granted.
