Fees shown above include all necessary consular and service fees as well as the cost to return your passport(s) via FedEx within the continental U.S. (Please add \$33.00 to cover extra shipping costs for addresses in Alaska, Hawaii, or Canada.) We strongly suggest that you send your documents to us via FedEx or some other form of traceable overnight courier service.

Please enclose your actual passport along with one (1) photograph and one (1) completed visa application form for China. Please also include one (1) color photocopy of your driver's license or other state issued identification, two (2) clear photocopies of the vital information page of your passport and a copy of your paid flight or cruise itinerary showing entry into China. Please note that Chinese visa applications must be completed online at the link shown herein. (If you reside in any of the following states: TX, OK, AR, LA, MS, AL, GA or FL and are traveling to China for the first time you must complete the enclosed China Visitation Letter. If you have traveled to China at any time in the past you must submit a photocopy of your last Chinese visa as well as the entry stamp that was placed in your passport, if you do not possess these items than you must complete the enclosed China Explanation Letter.) Photographs should be recently shot passport-type photos with a clear background approximately 2" x 2" in dimension. (Note that machine or home photographs are not acceptable and photos must be different than those in your current passport. You must be wearing a dark shirt without pattern, your hair may not be covering your ears and you cannot be wearing jewelry or eyeglasses.) Your passport must be signed and valid for a minimum of twelve (12) months beyond the completion of your travel or until November 4, 2020 and must have at least four (4) blank unused pages available not including those reserved for amendments and endorsements at the back of your passport. Contact PTDS directly for assistance with the renewal of your U.S. passport, as this can easily be done at the same time you apply for your visas.

Applications must be received in our offices no fewer than 45 days prior to your departure from your shipping address or by September 6, 2019 whichever is sooner. Documents received after the deadline will be subject to the *per person* late fee shown above. Special requests for passports to be expedited due to other travel plans prior to your tour departure may also require expediting fees. Please contact PTDS directly regarding any special processing needs or before submitting documents you expect may be received substantially after the deadline as there may be special requirements and/or additional fees to process your request. It may not be possible to cancel processing of your applications once they have been submitted.

In addition, your passport must be signed and valid for twelve (12) months beyond the completion of your international travel. If you are a U.S. citizen and do not have the adequate number of pages or validity you will need to renew your passport since the U. S. Passport Agency will no longer add pages. Pinnacle Travel Document Systems can easily assist you with this at the same time your visas are being processed. The total additional fees for this service (including U.S. government expediting fee) is \$276.00 for passport renewals and second passports. We can also assist you with expediting first time passport applications.

### APPLICATION COMPLETION SERVICE

We will complete your online visa application(s) for you as an optional service if you are not able to or simply prefer not to go through the online process on your own.

You must still provide all the necessary personal information in order for us to be able to provide this service. A hand written manual version of the visa application(s) must be completed and returned to us before you actually send in your passport and other required documents for visa processing.

Once we have received your completed manual visa application form(s) we will execute the online form on your behalf and return it to you within 2 working days. You will then need to sign this form and include it with your passport, photographs and other documents being sent to us for processing of your visa(s).

Please note that this service is separate from the actual processing of your visa(s) and you must wait to receive and then sign the completed online version of the visa application form(s) from us before you physically ship your documents to us for visa processing.

The fee for this service is \$75.00 per application, per person payable via credit card at the time you send the manual version of the application(s) to us and is in addition to the visa processing fees quoted.

Please click on or carefully type the link exactly as shown above directly into your web browser address window and NOT into your search engine, e.g. Google or Yahoo otherwise you will not reach the application. When you click on the link for the Chinese visa application it may open in a new tab in your browser rather than in Adobe Reader. You may not be able to input data to the fillable fields and/or print the form. Alternatively you may prefer to right click and save the actual document to your desktop and then open it from there using Adobe Reader which should allow you to complete and print the form. If you are using a MAC please note that the Safari web browser may not be fully compatible with the online visa application process so you may need to use Chrome web browser instead.

All fields must be typed and fully completed. No handwritten forms will be accepted. All questions that cannot be answered must say N/A or none. No handwritten marks can be made on form other than your signature.

Please print the online form and include it with your documents. All forms must bear your original signature.

### TIPS FOR COMPLETING CHINESE VISA APPLICATION

Pinnacle Travel Document Systems strongly recommends printing this tip sheet and using it as a guide while you are completing the Chinese application. Below is an explanation on how to avoid the most common errors that applicants make while filling out the application. Failure to follow instructions will cause your application to be rejected by the Chinese Embassy/Consulate and result in delays in issuing your visa.

#### Question 1.1

Name MUST match the name in your passport.

#### Question 1.2

Former Chinese citizens must write their name in ethnic script.

#### Question 1.3

Maiden name, Former married names, ETC.

#### Question 1.9

Driver's License number or Social Security Number.

#### Question 1.10

If you have a blue US passport the correct answer is "Ordinary".

#### Question 1.15

If retired please state retired and from what position.

Residents of AL, AK, FL, GA, LA, MS, OK, TX and PR do not need to state from what profession they retired from.

#### Question 1.17

If you are a retired worker please include your previous employers contact information. Students must include school contact information. Residents of AL, AK, FL, GA, LA, MS, OK, TX and PR who are retired should type N/A in each field.

#### Question 1.18

Physical addresses only. No P.O. box numbers allowed.

#### Question 1.23

Must list major family members, Father/Mother, Husband/Wife and children.

#### Question 2.6

Fill in the dates of stay in each location. Fill in names, addresses and phone numbers for all hotels or other residences you will stay in.

#### Question 2.8

Fill in the details of your hotel, tour operator or private host in China.

#### Question 3.8

USA citizens must answer N/A to all nine fields.


