Silversea recommends guests obtain a visa for India prior to departure to avoid significant delays upon arrival to India.

However if you prefer you can obtain an E-visa at Indian eTourist Visa

Your E-visa must be validated when you arrive in India and this process can take several hours. Please bring a copy of the printed confirmation for your E-visa with you to the ship at the time of boarding. Electronic Travel Authority required for Sri Lanka must be obtained prior to travel – apply online at http://www.traveldocs.com/uploads/forms/SriLankaTETA.pdf

The ETA is submitted online, the ETA approval will be returned via email.

Visas not required for short tourist stays in Seychelles and Maldives.

Given persistent delays with processing, your Indian visa may not be obtainable if documents are received after the deadline. Visas for India must be processed in your country of legal residence.

Please use enclosed sample information verbatim and substitute your personal information.

Please note that after your India visa is complete, your passport will be returned to you directly from the Indian Consulate to the address on your driver's license and India visa application. Each passport will be returned individually as they are processed and each applicant will receive an email from the Indian consulate with overnight FedEx tracking information. This is the result of recent changes to Indian government regulations and unfortunately no exceptions will be made in terms of the designated return shipping address.

Fees shown above include all necessary consular and service fees as well as the cost to return your passport(s) via FedEx within the continental U.S. (Please add \$32.00 to cover extra shipping costs for addresses in Alaska, Hawaii, or Canada.) We strongly suggest that you send your documents to us via FedEx or some other form of traceable overnight courier service.

Please enclose your actual passport along with two (2) photographs and one (1) completed visa application form for India. Please also include one (1) color photocopy of your driver's license or other state issued identification, two (2) clear photocopies of the vital information page of your passport and one (1) completed Additional Particulars Form for India. Note that your India visa application must be completed online at the link shown herein. Photographs should be recently shot passport-type photos with a clear background approximately 2" x 2" in dimension. (Note that machine or home photographs are not acceptable, you may not be wearing eyeglasses in your photos and photos must be different than those in your current passport.) Your passport must be valid for a minimum of six (6) months beyond the completion of your international travel or until August 14, 2018 and must have at least four (4) blank unused pages available, not including those reserved for amendments and endorsements at the back of your passport. Contact PTDS directly for assistance with renewal of your U.S. passport, as this can easily be done at the same time you apply for your visas



Documents received after the deadline will be subject to the per person late fee shown above. IMPORTANT NOTICE - PASSPORT PAGES & VALIDITY:

You must have at least four (4) blank unused pages available in your passport for visas and entry/exit stamps. In addition, your passport must be valid for six (6) months beyond the completion of your international travel. If you are a U.S. citizen and do not have the adequate number of pages or validity you will need to renew your passport since the U.S. Passport Agency will no longer add pages. Pinnacle Travel Document Systems can easily assist you with this at the same time your visas are being processed. The total additional fees for this service (including U.S. government expediting fee) is \$276.00 for passport renewals and second passports. All dates on the form are in DAY/MONTH/YEAR format.

No handwritten applications will be accepted.

Please print the online form and include it with your documents.

Application forms must be printed on two separate pieces of paper.

Application forms printed back to back on a single page are NOT accepted.

All forms must bear your original signature.

Indian visa applications must be perfect. Errors or omissions cannot be edited or fixed by PTDS. No marks allowed on applications other than applicant signature. Please be careful when completing your application to avoid delays.

Applicants are required to sign the visa application in two places. On page one, the applicant must sign COMPLETELY inside the box located under the photo area, if any part of the signature is outside of the box the application WILL be rejected. On page two, the applicant must sign on the dotted line at the bottom of the page. If the applicant is a minor, both parents or legal guardians must sign the application. Both signatures must be COMPLETELY inside the box located on page one.

Your application MUST be signed EXACTLY as you have signed your passport. For example if you have signed with your full middle name or initials the signatures must match.
